Liaison Reports (brief summary of OP & RF Reports):

Oak Park: The board attended a presentation on the Youth Services budget. The board is also continuing to review their goals/objectives. They've noticed a lot of agencies struggling as state funding decreases.

River Forest: RF will hopefully have a new committee member, pending approval. The first few Sibshops are up and running. Last week RF held an all day mental health/first aid training that was well received. There were a lot of D97 (Principals, Social Works etc.) representatives present. At the training there was exposure to mental illness with an emphasis on suicide awareness.

New Business: Contract Review

RIVER FOREST:

Rationale: During the site visit, committee members found that it was an open and welcoming environment. They believe the service to the youth has improved since last year and saw program administrators were engaged with the kids.

- River Forest Police Department- ISearch

Rational Committee members feel that this program is beneficial and worth it for the amount of people in the community it serves.
