**WHEREAS**, Above all, Greg White was loyal, consistent, and committed; He believed in the work and value of the township; whether it was keeping records organized and available to the public, making sure that elections ran smoothly, or just by his presence at the board table or at township and community events, he rarely missed any opportunity to be of service to his community; and

**WHEREAS**, Greg White's presence and dedication will be missed by all of us at the township and in the Community;
